## DOCUMENTATION A FOURNIR

### STUDY TRAINING RESEARCH VISAS

- *These visas allow you to stay in Spain to carry out one of the following non-professional activities.*
- *- Completion or extension of studies at an accredited educational center in Spain, in a full-time program, leading to a diploma or certificate of studies.*
- *- Conducting research or training activities.*
- *- Participation in a student mobility program, to follow a secondary education program in an officially recognized teaching or scientific center.*
- *- Carrying out non-work-related practices in a public or private organization or entity.*
- *- To provide voluntary service as part of a program that pursues objectives of general interest.*
- 
- *The visa is valid for between 91 and 180 days, or for more than 180 days.*
- 
- **DOCUMENTS REQUIRED**
- 
- *o National visa application form, duly completed and signed.*
- 
- *o One recent color passport photo with white background.*
- 
- *o Valid passport or travel document valid for longer than the period of your stay in Spain (original and copy).*
- 
- *o Certificate of enrolment in a study center and proof of payment of tuition fees. The study center must be approved by the Spanish authorities: by the Autonomous Community where it is located or by the Ministry of Education.*
- 
- *o Program of study, training or research (address and name of training center, types of study to be carried out, duration of training, course timetable).*
- 
- *o Originals and copies of diplomas\* of studies completed, indicating the level acquired, legalized by the Ministry of Foreign Affairs of the country where the study center is located and by the Spanish Embassy.*
- 
- *o Proof of availability of accommodation in Spain covering the study period.*

## DOCUMENTATION A FOURNIR

- 
- *o Proof of financial solvency: accreditation of personal financial resources covering the costs of studies, subsistence and accommodation throughout the period of study in Spain, and guaranteeing, if necessary, a return to the country of origin.*
- 
- *o Medical insurance covering the entire period of stay in Spain, covering medical expenses and repatriation in the event of accident or sudden illness, for a minimum amount of 30,000 Euros.*
- 
- *o Students under the age of 18, if not accompanied by their parents or legal guardians, must also provide a notarized authorization from the latter, mentioning the name of the study center and the expected duration of the stay.*
- 
- *o If the requested stay is longer than 6 months:*
  - *- Original and copy of the medical certificate\* proving that the applicant does not suffer from any of the diseases that could have serious repercussions on public health, in accordance with the provisions of the 2005 International Health Regulations. It must be legalized by the Ministry of Justice (Direction des Affaires Civiles et du Sceau), the Mauritanian Ministry of Foreign Affairs and the Spanish Embassy.*
  - *- For applicants over the age of 14: original and copy of a clean criminal record\*, issued by the authorities of the country in which the applicant has resided for the last 5 years, in which there should be no convictions for offences under Spanish law, legalized by the Ministry of Foreign Affairs of the said country and by the Spanish Embassy. If it is from a country other than Mauritania, it must be legalized by the Spanish Embassy in that country.*
- 
- *o The processing fee is MRU 9,510, to which may be added the additional costs of the receiving company.*
- 
- *\*Documents to be completed at the Embassy before going to your BLS appointment:*
  - *- Legalize medical certificate, criminal record and diplomas, by appointment only, by calling +222 45 25 20 80.*
